

Scentsy's 15th Year Celebration US and Canada Sweepstakes Rules

1. NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

2. SPONSOR: The sponsor of the Sweepstakes is Scentsy, Inc., 2701 E. Pine Avenue, Meridian, Idaho 83642. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply and abide with these rules and the decisions of Scentsy, which shall be final and binding in all respects.

3. TERM: Scentsy's Fifteenth Year Celebration Contest begins May 13, 2019, at 12:00am (PST) and ends August 25, 2019, at 11:59 p.m. (PST).

4. ELIGIBILITY: This Sweepstakes is open to Scentsy fans of the 50 United States of America and the District of Columbia, and in Canada (excluding Quebec). American residents must be 18 years of age or older at the time of entry, and Canadian residents must be 19 years of age or older at the time of entry. Residents of Puerto Rico and Quebec, Canada are not eligible to participate. Canadian residents must correctly answer a timed math question (less than ten minutes), without assistance from any machine or person, in order to win. Employees of Scentsy, members of employees' immediate families (e.g. spouses, children, siblings, parents), and persons living in the same household as employees' or employees' immediate family members are not eligible to participate in the Sweepstakes. Scentsy, will determine the winner's eligibility in Scentsy's sole and absolute discretion.

7. HOW TO WIN: A participant may enter in one of two ways. First, each purchase of a scentsy whiff box during the contest period will automatically enter the purchaser into the sweepstakes. Second, and alternatively, a participant can send an email to scentsycontest@scentsy.com, including the name, address, phone number, and a reference to the contest above. The email must be received by Scentsy by 11:59pm PST on August 25, 2019. Each person is only allowed one entry by way of email.

8. INFRINGING SUBMISSIONS. Submissions that violate or infringe upon another person's rights, including but not limited to copyrights, trademark rights, or other intellectual property, are not eligible. By entering the Sweepstakes, you agree to indemnify Scentsy, from any claims arising from the use of your entry, including but not limited to intellectual property infringement, infringement of right of publicity, or any other moral rights or rights of authorship your submission may infringe.

9. USE OF INFORMATION PROVIDED TO SCENTSY. By entering the Sweepstakes, you give Scentsy permission to notify others of the Sweepstakes winners if law requires. Any and all submissions become the property of Scentsy. If applicable, Scentsy reserves the right to edit and publish any grammatical or spelling errors in the entry. If you submit any creative suggestions, ideas, notes, drawings, concepts, designs, original artwork or other information, you assign to Scentsy all of your rights in and to them without compensation or payment of any kind. Scentsy

reserves the right to publish the names and contact information of the winners to any governmental body, should it be requested to do so. Prizes will include, but are not necessarily limited to: Scent of the Month products, wax warmers, wax bars and/or bricks, diffusers, diffuser oils, laundry products, Whiff Boxes, cleaning products, bath bombs, Scentsy Pods, room sprays, body creams, body washes, hand creams, hand soap, Scentsy Go products, Scent Paks, Scent Circles, Scentsy Buddies, Scentsy's newly released products, and combinations of the foregoing. Prizes will be shipped directly to the winners at the address they provide to Scentsy. Prizes may not be exchanged or returned for any monetary amount. Scentsy reserves the right to substitute or change any prize of equal or substantially similar value for reasons including, but not limited to, product availability. Only the type and quantity of prizes described in these rules will be awarded.

12. ESTIMATED ODDS: The estimated odds of winning will depend on the number of entries, and thus are unknown, but are estimated to be at 1:275.

13. NOTICE TO WINNERS:

Winners that enter via a Whiff Box purchase will be issued a golden ticket in their purchase notifying them that they won. The Whiff Box and golden ticket will be shipped within 10 business days of order submission. Golden ticket recipients can claim their prize by calling Scentsy Consultant Support at 877.855.0617. Failure to notify Scentsy within 30 days of receipt of a golden ticket will result in forfeiture of win. Scentsy will then certify that the golden ticket is legitimate and ship the prize. Winners that enter via email will be notified via email within 10 business days of their selection. If, despite reasonable efforts, a potential winner does not respond within thirty (30) days of an email notification (or such shorter time as exigencies may require), or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected. If any potential prize winner is found to be ineligible, or if she or he has not complied with these rules or declines the applicable prize for any reason prior to award, such potential prize winner will be disqualified and an alternate winner may be selected.

In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. In the event of a dispute regarding the winner, Scentsy reserves the right to award or not award a prize in its sole and absolute discretion. Scentsy reserves the right in its sole discretion to disqualify from these Sweepstakes, and ban from any future promotions, any individual who is found to be tampering with the entry process or the operation of the contest, to be acting in violation of these rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Sweepstakes, or to annoy, abuse, threaten or harass any other person, and Scentsy reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law.
